TERMS AND CONDITIONS FOR TARGA TASMANIA 2025

1. Introduction

These terms and conditions govern your participation Targa Tasmania (hereinafter referred to as the 'event'). By completing and submitting an 'Application to Enter' form to apply to participate in the event, you agree to be bound by the terms and conditions set out in this document and acknowledge that you have read and understood these terms and conditions.

2. Preamble

The following words have the following meanings:

- A. **Australian Consumer Law** means Schedule 2 of the *Competition and Consumer Act 2010* (Cth) and any equivalent State or Territory legislation.
- B. **Application to Enter** means an application with Targa for a vehicle to compete in a competition section of the event.
- C. **Entry Form** means an application with Targa for a vehicle to participate in a tour section of the event.
- D. **Fees** means the entry fee, as notified by Targa, payable by you to Targa in respect of your participation in the event.
- E. **Health Condition** means any impairment of your mental or physical condition, including but not limited to any of the following.
 - 1. recent stroke.
 - 2. surgery or illness.
 - 3. heart or respiratory conditions, or cardiac disease.
 - 4. neck or back pain, ailments, or weakness.
 - 5. broken bones or joint or limb ailments.
 - 6. high blood pressure or aneurysms.
 - 7. diabetes (on insulin therapy).
 - 8. epilepsy.
 - 9. prescription medication that may adversely affect your participation in the activity; or
 - 10. any other pre-existing medical condition that prevents safe participation, including pregnancy, in the event.
- F. **Vehicle** means the vehicle you specify in the Application to Enter form to participate in the event.
- G. **Event** means Targa Tasmania for which you have made your Application to Enter on Entry Form.

3. Organiser

The organiser of the event is Targa Australia Pty Ltd ACN 092 438 992

4. Contract

A binding contract between you and Targa for your participation in the event in accordance with these terms and conditions will arise as soon as:

- A. Targa has accepted your application to enter in the event as set out in the Application to Enter form by sending you written confirmation of your application and your invitation to compete; and
- B. Targa has received full payment of your entry fee; and
- C. Targa has received all required documentation.

Participation in the event will not be permitted if Targa have not received all required documentation duly executed by you.

5. Entering a Competition in this Event

You cannot directly enter the competition sections of this event. Competitors wishing to compete in this event are required to submit an 'Application to Enter Competition' form, which requires the details of the competition crew, their previous Targa competition history and all details relating to the vehicle in which they wish to compete. No deposit is required at this time and submitting this form does not secure an entry in the event or declare any intention by Targa to grant an entry to the competition crew submitting the application to enter form.

Application forms will be assessed by Targa in the order they are received, and competition crews will receive back information within twenty-one working days that outline Targa's decision to accept or decline the application. In some instances, further information may be required to assess the application.

If accepted, the competition crew will be issued with an 'Invitation to Compete' advising the competition in which the crew will be placed for this event, all information and guides relating to the event and an entry fee tax invoice for payment within thirty days. The 'Invitation to Compete' only becomes valid on receipt by Targa of full payment of the entry fee tax invoice.

Targa reserves the right to decline any 'Application to Enter Competition' without giving a reason. Targa also reserves the right to withdraw a previously issued 'Invitation to Compete' without giving a reason. In all cases where an application is declined or withdrawn, entrants will be advised of this decision in writing.

'Application to Enter Competition' forms are to be lodged with Targa by clicking the submit button shown on the application form. The form must be fully completed to be considered a valid 'Application to Enter Competition'. 'Applications to Enter Competition' may be submitted after the close of applications date at the discretion of Targa.

Targa reserve the right to amend or cancel the specific competition or section of the event, which you have applied to enter, without giving a reason and also reserve the right to move you and/or your vehicle to another competition or section of the event, up to the start of the event, without giving a reason.

Replacement crew members may be nominated before the event, but the nomination must be submitted using the correct form. Acceptance of the nomination will be at the discretion of Targa.

6. Medical Requirements - Competitions

All competitors, regardless of the competition entered, must submit a signed medical disclaimer confirming that he or she is medically fit to compete in the event. Competitors over 60 years of age must hold a current Motorsport Australia or Australian Auto Sport Alliance licence that has required them to undertake a medical examination.

This disclaimer must be dated after 17 September and submitted to Targa before the commencement of documentation.

Medical questionnaires for the purpose of providing Targa medical crews with accurate information, if needed, must also be completed, showing all current medications signed and submitted at documentation.

7. Eligibility Criteria

A minimum criterion is required to apply for entry into each competition. This is outlined in the table on the following page. It is important for each crew member to assess their eligibility level before applying to enter this event. Competition eligibility will be based on the crew member with the least amount of Targa experience.

7. Entering a Tour in this Event

Participants wishing to take part in the tour section in this event are required to submit an 'Application to Enter Tour Form', which requires the details of the participating crew and all details relating to the vehicle in which they wish to participate. No deposit is required at this time and submitting this form does not secure an entry in the event or declare any intention by Targa to grant an entry to the participating crew submitting the application to enter form.

Application forms Entry forms will be assessed by Targa in the order they are received, and participating crews will receive back information within twenty-one working days that outline Targa's decision to accept or decline the entry. In some instances, further information may be required to assess the application.

If accepted, the participating crew will be issued with an 'Invitation to Participate' advising the tour in which the crew will be placed for this event, all information and guides relating to the event and an entry fee tax invoice for payment within thirty days. The 'Invitation to Participate' only becomes valid on receipt by Targa of full payment of the entry fee tax invoice.

Targa reserves the right to decline any 'Application to Enter Tour Form' without giving a reason. Targa also reserves the right to withdraw a previously issued 'Invitation to Participate' without giving a reason. In all cases where an application is declined or withdrawn, participants will be advised of this decision in writing.

'Application to Enter Tour Forms' are to be lodged with Targa by clicking the submit button shown on the entry form. The form must be fully completed to be considered a valid 'Application to Enter Tour Form'. 'Application to Enter Tour forms may be submitted after the close of entries date at the discretion of Targa.

Targa reserve the right to amend or cancel the specific tour or section of the event, which you have applied to enter, without giving a reason.

Targa reserve the right to move you and/or your vehicle to another tour section of the event, up to the start of the event, without giving a reason.

Replacement crew members may be nominated before the event, but the nomination must be submitted using the correct form. Acceptance of the nomination will be at the discretion of Targa.

A Blue Chip will only be issued to a participant at the completion of the compulsory tour briefing, . A Blue Chip is valid for this event only and each participant must hold a Blue Chip to participate at any time. Targa reserves the right to withdraw a Blue Chip at any time, even during the event, without giving a reason.

8. Medical Requirements - Tours

All participants, regardless of tour type entered, are required to submit a medical disclaimer, showing all current medications and confirming that he or she is medically fit to participate in the event. This disclaimer must be dated after 17 September and submitted to Targa before the commencement of documentation.

Medical questionnaires for the purpose of providing Targa medical crews with accurate information, if needed, must also be completed, showing all current medications signed and submitted at documentation.

9. Entry Fees and Levies

All entry fees and levies must be paid to validate an Invitation to Compete/Participate and by the closing date of applications. If any entry fee is not received in full by this date, Targa reserve the right to withdraw the invitation and allocate the vehicle number to another invited applicant.

Entry fee inclusions will be shown on the tax invoice provided by Targa with the Invitation to Compete/Participate.

Any withdrawal once full payment has been received by Targa will not be entitled to a refund at the sole discretion of Targa.

Targa reserve the right to charge additional fees (levies), as required, for third party providers or unforeseen circumstances. These fees will be advised to all crews who have received an Invitation to Compete no less than 30 days before the commencement of the event.

10. Acceptance of Invitation

An 'Invitation to Compete/Participate' is issued by Targa at their sole discretion. Any such invitation applies only to the nominated entrant, the nominated driver & co-driver, and the nominated vehicle as shown on the Application to Enter or Entry Form.

An entrant wishing to change the vehicle, or any crew member, originally nominated after an 'Invitation to Compete/Participate' has been issued, must notify Targa who, at their sole discretion, reserve the right to withdraw the original invitation and consider the proposed replacement vehicle, or any crew member, as a new application. Targa reserve the right to decline an 'Invitation to Compete/Participate' in the event without giving a reason.

Targa owns all vehicle numbers and reserves the right to allocate any number to who it decides and can change any vehicles allocated number without giving a reason.

It is a condition of entry that from the successful completion of each vehicle's pre-event vehicle check form and pre-event tyre-marking, the vehicle is subject to security park conditions as set down in these terms and conditions.

It is also a condition of the invitation that it is acknowledged a \$15,000 excess is in place for all property damage caused by competition crews and tour participants at this event.

In accepting an invitation to compete/participate you acknowledge, warrant, and represent to Targa that, you have (or will) read, accept, and agree to be bound by all rules, regulations, guides and all written material provided to you by Targa.

- A. all details provided by you on your entry form/s are true and correct.
- B. you have sufficient experience in driving vehicles, including driving at high speeds, and understand all the risks involved in driving a vehicle.
- C. you have not been charged with any serious road offence, including, but not limited to, any road related death or dangerous driving charges.
- D. at all times during the event, you will:
- E. be a minimum age of 18 (16 for tours) and provide evidence of such at the request of Targa.
- F. have a current valid full Australian driver's licence or a current valid overseas driver's licence recognised in the jurisdiction in which the event is held.
- G. hold a valid blue chip.
- H. comply with all rules in relation to the event provided by Targa.
- I. comply with all applicable laws.
- J. comply with all directions issued by Targa, including, but not limited to, all training and briefings prior to taking part in the event, wearing any required safety equipment and any warnings of driving or speed infringements.
- K. notify Targa of any accident in which you are involved.
- L. not be under the influence of any alcohol, legal or illegal drugs or substances that may impact on your ability to participate in the event, including your ability to drive a vehicle; and
- M. not be affected by any health condition or will provide written certification from your physician that the health condition will not affect your participation in the event and will not be aggravated by your participation in the event.

By participating in the event, you agree that you must,

- A. allow Targa to install a RallySafe, or similar tracking unit into your vehicle or agree to use a provided application on your mobile phone.
- B. you will provide a suitable power source for this unit or your mobile phone.
- C. not interfere with any RallySafe or similar tracking unit.
- D. regularly inspect your vehicle during the event and ensure that it is in a roadworthy and safe condition before driving the vehicle or allowing it to be driven.
- E. ensure that your blood alcohol concentration is 0.00 at the commencement of each day of the event, and maintain this level throughout each day of the event; and
- F. submit to daily blood alcohol breath tests along with random blood alcohol and drug tests, which can be conducted at any time during the running of the event.

Due to the nature of the event, your participation and usage of your vehicle in the event is at the sole and absolute discretion of Targa. Targa may refuse to allow you to compete/participate, suspend or ban you from competing/participating in any part of or whole of the event, at any time, in its absolute discretion, including if,

- A. you breach any term of these terms and conditions.
- B. a warranty or representation provided by you is, or at any time becomes, untrue or inaccurate.
- C. Targa determines, in its absolute discretion, that you are mentally or physically unfit to participate in any aspect of the event.
- D. Targa determines, in its absolute discretion, that your vehicle is not roadworthy, or it is not safe for your vehicle to participate in the event; or
- E. you fail to pass a blood alcohol breath or drug test.

11. Warranty

Subject only to clause 4, Targa does not provide any warranties that the event (or any services in relation to the event) will be provided with due care and skill or that any materials or equipment provided in connection with the event will be fit for the purposes for which they are supplied. To the fullest extent permitted by any law, all conditions and warranties implied by law arising out of or in connection with the supply of the event by Targa, are excluded.

12. Australian Consumer Law

Targa acknowledges that you may have certain rights under the Australian Consumer Law in respect of the event and nothing in these terms and conditions should be interpreted as attempting to exclude, restrict or modify the application of any such rights. To the extent of any inconsistency between any of those rights you may have and these terms and conditions, those rights will prevail, other than any of those rights that are lawfully excluded under the Deed(s) of Release and Indemnity or any of the other event documents (as that term is defined in the regulations and online entry system).

Subject to the Australian Consumer Law and any other applicable law, Targa will not provide any refunds in respect of the Entry Fees in the event of a cancellation of your entry were,

- A. you change your mind.
- B. there is a change in your personal circumstances.
- C. you do not attend the event, or you only compete/participate in part of the event; or
- D. there is inclement weather or any other unforeseen conditions during the event that prevent the event from proceeding.

13. Insurance

A. Third Party Property Insurance

Limited third-party property insurance for the event will be provided for competition and tour blue chip holders in accordance with Targa's property insurance policy. Details of this cover will be made available by the close of entries date. Each crew is liable for all damage which they cause, however they may make a claim under this insurance to compensate them for the cost of that damage. It is a condition of the invitation to compete/participate that it is acknowledged an excess of \$15,000 is payable where a claim is made. If the cost is less than this excess, the crew is required to pay only the actual cost of rectification. (Note: It is the crew responsibility to report any property damage they cause – no matter how minor – by filling in the property damage form included in the road book. Any failure to report or pay for damage as required under these regulations will be referred to the Clerk of the Course for review and an appropriate penalty applied).

However, you will need to make your own enquiries as to whether the property insurance is available to you and agree that all insurance arrangements are ultimately your responsibility.

B. Personal Accident Insurance

Limited personal accident insurance for each driver, co-driver, service crew member and authorised official in this event will be arranged and paid for by Targa. Details of this cover will be made available by the close of entries date. Each crew member is responsible for paying all costs relating to any medical expenses resulting from an accident in the event. A claim may be made through the provision of the insurance. (Note: competitors are strongly advised to ensure that they are covered by an Ambulance Fund).

You will need to make your own enquiries as to whether the personal accident insurance is available to you and agree that all insurance arrangements are ultimately your responsibility.

C. Vehicle Compulsory Third Party Insurance

All vehicles must carry any compulsory third-party insurance, which is normally issued with, or as a requirement of the vehicle registration. Proof of cover is required to be presented at documentation (registration papers or temporary permit). Where a participant is required by law to carry compulsory third party insurance, the Targa Public Liability Policy is inoperative to the extent of such compulsory third-party insurance. Owners of vehicles registered in the State of Queensland are required to obtain a special extension of their compulsory third-party insurance for the period of the event from their third-party insurer. Proof of this third-party insurance extension must be presented at documentation. Where state law either does not address or specifically excludes compulsory third-party insurance, then the individual liability of the participant is covered by the Targa Public Liability Policy (subject at all times to the Targa Public Liability Policy's conditions, limitations, disqualifications, and deductibles where applicable).

D. Vehicle Third Party Property / Comprehensive Insurance

Personal, vehicle and third-party property insurance and/or comprehensive insurance is your sole responsibility, and you acknowledge that any loss, damage, cost, expense, liability, claim, action, proceeding or demand that you suffer or incur will not be covered under any insurance policy held by Targa.

NOTE: Your vehicle is not automatically covered by your comprehensive insurance on a Targa stage. Targa strongly recommends that you discuss your policy with your insurance provider to ensure you have additional cover in place before the start of the event.

E. Cancellation Insurance

Should the event be cancelled by Targa more than seven days before the event starts, for whatever reason, the applicant will receive a full refund of entry fees paid at this time. Should the event be shortened, altered or interrupted in any way, within seven days of the event starting and during the running of the event, Targa will not have any liability to you in relation to any losses, damage, costs, expenses or liabilities you may suffer or incur as a result of or arising out of such alteration or interruption, including any travel and accommodation expenses you may have incurred, unless required by law (including under the Australian Consumer Law).

Should the event be cancelled after it has commenced due to a fatality, the applicant will receive a pro rata refund of their entry fee based on the remaining days of the six-day event. In this instance, Targa will not have any further liability to you in relation to any losses, damage, costs, expenses or liabilities you may suffer or incur because of such cancellation, including any travel and accommodation expenses you may have incurred, unless required by law (including under the Australian Consumer Law).

F. Other Compulsory Insurance

Each crew is responsible for paying the cost of any other compulsory insurance required by Targa or Tasmanian State Government authorities. If any such cover is required, crews will be advised in a bulletin.

14. Copyright

The entrant agrees all photography, video and film rights for the event are the property of Targa. Competitors/participants are permitted to carry video cameras in their vehicles for the purpose of making moving or still picture records for their private viewing, but Targa retain copyright of all photographic and/or film/video footage associated with the event. No movie, film or video taping of any part of the event shall be carried out by the entrant or crew member other than with the express approval, in writing, of Targa. Any commercial arrangements made by the entrants and crew members for the sale of film or video/still footage, or viewing of such footage in a public place, must be approved in writing by Targa. Entrants and crew members are advised to contact Targa prior to making commitments for any such commercial arrangement.

The entrant agrees all data obtained by the RallySafe or similar tracking device for the event is the property of Targa and competitors can only obtain and use this data with the written permission of Targa. Failure to observe these regulations may lead to legal action by Targa for a breach of copyright. All crew members agree to the use in perpetuity of their names and photographs, and photographs of their vehicles, in publicity material issued by Targa or the event sponsors and to comply with the film and video regulations.

All crew members agree that their names and contact details may be made available to and be used by sponsors and licensees of the event. Targa have the right in perpetuity to authorise the production, distribution and sale of models, photographs or other forms of reproduction of any vehicle participating in the event, in competition livery (including drivers, co-drivers and navigator names) for event-related promotions. By signing up for a Targa event, you agree to subscribe to newsletters, marketing or promotional materials and other information Targa may send. However, you may opt out of receiving any, or all, of these communications from us by following the unsubscribe link on any Targa promotional correspondence.

15. Health

You acknowledge that you are choosing to attend an event where you may be exposed to diseases (including before and while you are attending the event). It is your own responsibility to acquaint yourself with all relevant information, including applicable health risks. You acknowledge that your decision to participate in the event is based on your own consideration of this information, and you acknowledge and agree that you are aware of, and assume responsibility for, the risks associated at this time. To the fullest extent permitted by law, we accept no liability in relation to these additional risks. The event will be held in conjunction with the local State Government rules and regulations, which are in place at the time of the event. You agree to comply with any applicable rules and regulations together with any reasonable directions which may be issued by Targa to ensure the safety of all participants of the event.

16. Governance

These terms and conditions are governed by the laws in force in the State of Victoria and the parties submit to the non-exclusive jurisdiction of the courts of the State of Victoria.

17. Porsche Targa Tour Only

Please note that by signing up for the Porsche Targa tour, Porsche Cars Australia's Terms and Conditions also apply. Porsche Cars Australia's terms and conditions were agreed to at the time of your registration with Porsche Cars Australia. Porsche Cars Australia's cancellation and refund policies supersede those that are defined in Targa's terms and conditions.
